The projected amount of American debt in the next few years equals 100 percent of the U.S. GDP.

The U.K. holds \$230.7 billion of the U.S. debt.

Brazil holds \$156.2 billion in U.S. debt.

Hong Kong has \$142.0 billion of the American debt.

Russia has \$122.5 billion of American debt.

Luxemburg holds \$90.8 billion of the American debt.

Taiwan has \$78.7 billion of America's debt.

Switzerland owns \$71.5 billion of America's debt.

Germany holds \$52.8 billion in American debt.

South Korea has \$42.2 billion of the U.S. debt.

Canada has \$40.8 billion in American debt.

Ireland has \$38.3 billion in U.S. debt.

France has \$36.2 billion in U.S. debt.

Singapore has \$35.2 billion of the U.S. debt.

India owns \$32.9 billion of the American debt.

Turkey owns \$30.4 billion of the U.S. debt.

Thailand holds \$30.1 billion in U.S. debt.

Norway holds \$24.9 billion in American debt.

Mexico holds \$20.7 billion of U.S. debt.

As they did at Normandy, Peleliu, Guadalcanal, Iwo Jima, and most recently in Iraq and Afghanistan; the combat units of Our Armed Forces have laid down their lives for the sake of the United States of America. (But there is another aspect of Our Armed Forces so few think about; they were willing to kill...which We shall come back to.) We must ask

Ourselves, “What made these men willing to sacrifice their lives for Our Nation?” It was their Will to die for God and Country if so need be to defend the Light of their Republic, and what it stood for, in the midst of a world ruled by political despotism and spiritual darkness. As Adolf Hitler noted in “Mein Kampf” - ' One cannot separate a Nation's religious beliefs and moral values from its political ideology.' When a member of the Armed Forces performs their Duties in light of war conditions, they are, beyond doubt, acting as many members of a “machine”; whose purpose is to kill and destroy the Adversary. Whether they are the foot soldier that kills one at a time, or whether they are members of a Naval or Aviation Unit that kills in one stroke by the tens, hundreds, and even thousands; they are all the Fist of a Political Body that has predetermined the death and destruction of another. Mercenaries and auxiliaries are useless and dangerous; and if one holds his state based on these arms, he will stand neither firm nor safe; for they are disunited, ambitious, and without discipline, unfaithful, valiant before friends, cowardly before enemies; they have neither the fear of God nor fidelity to men, and destruction is deferred only so long as the attack is; for in peace one is robbed by them, and in war by the enemy. The fact is, they have no other attraction or reason for keeping the field than a trifle of stipend, which is not sufficient to make them willing to die for you.

They are ready enough to be your soldiers whilst you do not make war, but if war comes they take themselves off or run from the foe; which I should have little trouble to prove, for the ruin of Italy has been caused by nothing else than by resting all her hopes for many years on mercenaries, and although they formerly made some display and appeared valiant amongst themselves, yet when the foreigners came they showed what they were. Thus it was that Charles, King of France, was allowed to seize Italy with chalk in hand; and he who told us that our Sins were the cause of it told the Truth, but they were not the sins he imagined, but those which I have related. And as they were the Sins of the People, it is the People who have also suffered the penalty..." Unquote

It is for this Cause that George Washington stated; "Of all the dispositions and habits which lead to Political prosperity, Religion and Morality are indispensable supports. In vain would that Man claim the tribute of Patriotism who should labor to subvert these Great Pillars of Human Happiness."

OUR SOCIAL PLIGHT

"A House divided against itself cannot stand." Jesus Christ

Whether one view the polarity existing between the Conservative and Liberal divisions, or whether one consider the vain and profitless babbles that fill the halls of Congress under this fading dispensation of the Republi-Crat Regime; the Truth of the Words uttered by Christ Himself are evident all around Us.

Our streets nightly resounded with the noise of their riot and debauchery; our peaceful Citizens were hourly exposed to shameful insults, and often felt the effects of their violence and outrage...

“But this was not all; as though they thought it not enough to violate our Civil Rights, they endeavoured to deprive us of the enjoyment of our Religious privileges; to vitiate our Morals, and thereby render us deserving of Destruction. Hence the rude din of arms, which broke in upon your solemn devotions in your Temples, on that Day hallowed by Heaven, and set apart by God Himself for his peculiar Worship.

Hence, impious oaths and blasphemies, so often tortured your unaccustomed ear.

Hence, all the arts which idleness and luxury could invent, were used to betray our youth of one Sex into Extravagance and Effeminacy, and of the other to Infamy and Ruin; and have they not succeeded but too well?

Has not a reverence for Religion sensibly decayed? Have not our infants almost learned to lisp curses, before they knew their horrid import? And must I be compelled to acknowledge, that even the noblest, fairest part of all Creation, have not entirely escaped their cruel snares? -- or why have I seen an honest Father clothed with shame; why a virtuous Mother drowned in tears...?

“But I forbear, and come reluctantly to the transactions of that dismal night, when in such quick succession we felt the extremes of grief,

astonishment, and rage; when Heaven in anger, for a dreadful moment suffered Hell to take the reins when Satan, with his chosen band, opened the sluices of New-England's blood, and sacrilegiously polluted our land with the dead bodies of her guiltless Sons...

“Let this sad tale of Death never be told, without a tear; let not the heaving bosom cease to burn with a manly indignation at the relation of it, through the long tracks of future Time; let every parent tell the shameful story to his listening children, till tears of pity glisten in their eyes, or boiling passion shakes their tender frames;

Dark and designing knaves, murderers, parricides! How dare you tread upon the earth, which has drunk the blood or slaughtered innocence shed by your hands? How dare you breathe that air, which wafted to the ear of heaven the groans of those who fell a sacrifice to your accursed ambition...?

“ But if the labouring earth doth not expand her jaws; if the air you breathe is not commissioned to be the minister of Death; yet, hear it, and tremble! The Eye of Heaven penetrates the darkest chambers of the Soul; and you, though screened from human observation, must be arraigned, must lift your hands, red with the blood of those whose Death you have procured, at the tremendous Bar of God...

“But I gladly quit this theme of death -- I would not dwell too long upon the horrid effects, which have already followed, from quartering regular troops in this Town; let our Misfortunes instruct posterity to guard against these Evils. Standing armies are sometimes, (I would by no means say generally, much less universally,) composed of persons who have rendered themselves unfit to live in Civil Society; who are equally indifferent to the glory of a George, or a Louis; who for the addition of one penny a day to their wages, would desert from the Christian Cross, and fight under the Crescent of the Turkish sultan; from such Men as these what has not a State to Fear? With such as these, usurping Caesar

passed the Rubicon; with such as these he humbled mighty Rome, and forced the Mistress of the World to own a Master in a Traitor...

“These are the men whom sceptred robbers now employ to frustrate the Designs of God, and render vain the bounties which His gracious hand pours indiscriminately upon His Creatures. “

John Hancock in 1774 at an Address of the Victims of the Boston Massacre.

This is no time for ceremony.

The questing before the Nation is one of awful moment to this Country. For my own part, I consider it as nothing less than a question of Freedom or Slavery; and in proportion to the magnitude of the subject ought to be the freedom of the debate. It is only in this way that We can hope to arrive at Truth, and fulfill the great responsibility which We hold to God

and our Country. Should I keep back my opinions at such a time, through fear of giving offense? I should consider myself as guilty of Treason towards My Country, and of an act of disloyalty toward the Majesty of Heaven, which I revere above all earthly kings...

“My fellow Americans, it is natural to man to indulge in the illusions of hope. We are apt to shut our eyes against a painful Truth, and listen to the song of that siren till she transforms us into beasts. Is this the part of Wise men, engaged in a great and arduous struggle for Liberty? Are We disposed to be of the number of those who, having eyes, see not, and, having ears, hear not, the things which so nearly concern their temporal Salvation? For my part, whatever anguish of spirit it may cost, I am willing to know the whole Truth; to know the worst, and to provide for it...

“I have but one lamp by which my feet are guided, and that is the lamp of experience. I know of no way of judging of the future but by the past. And judging by the past, I wish to know what there has been in the conduct of the Republi-Crat Regime for the last twenty years to justify those hopes with which gentlemen have been pleased to solace themselves and the Nation. Is it that insidious smile with which our grievances have been lately received? Trust it not, sir; it will prove a snare to your feet. Suffer not yourselves to be betrayed with a kiss.

Ask yourselves how this gracious reception of our grievances comport with those warlike preparations which cover our waters and darken our land. Are domestic spies and FEMA Detention Centers necessary to their work of service and fidelity? Have We shown ourselves so unwilling to be deceived that force must be called in to win back our love?

Let us not deceive ourselves, sir. These are the implements of war and subjugation; the last arguments to which despots resort. I ask gentlemen, sir, what means this martial array, if its purpose be not to force us to submission? Can gentlemen assign any other possible motive for it? Has the Republic a mass enemy, in this quarter of the world, to call for all this accumulation of federal spies and mass prison constructions?

“They tell us, sir, that We are weak; unable to cope with so formidable an adversary. But when shall We be stronger? Will it be the next week, or the next year? Will it be when We are totally disarmed, and when a federal and/or UN soldier shall be stationed in every house? Shall We gather strength by irresolution and inaction? Shall We acquire the means of effectual resistance by lying supinely on our backs and hugging the

delusive phantom of hope, until our enemies shall have bound us hand and foot? Sir, We are not weak if We make a proper use of those means which the God of nature hath placed in our power. The millions of people, armed in the Holy cause of Liberty, and in such a country as that which We possess, are invincible by any force which our enemy can send against us. Besides, sir, We shall not fight our battles alone. There is a just God who presides over the destinies of nations, and who will raise up friends to fight our battles for us, and Our own Sons and Daughters who serve in the military will turn against them. OUR POLITICAL PLIGHT

The word “Politics” is an enigma in its own right when evaluated from an investigated conclusion as pertaining unto its actually perceived meaning, and therefore projected response from an individual. This circumstance has had a recurring appearance throughout History for various subject matters for which cause it has earned its own entitlement within the English language, and given the “birth name” of “semantics.” Semantics, in a “nutshell,” may be perceived by the imagined argument over whether

the creature in question is a “cat”; or a “feline”; both are correct, for the furry creature goes “meow.” Therefore, “semantics” is the attempted implied meaning behind words orchestrated to provide a specific comprehensive grasp; though the wording is different, the implied meaning is the same.

There is, however, another aspect of today's “politics” which goes beyond the semantics many try to label it, and transcends into illusion and myth.

In 1962, John F. Kennedy gave a speech in which was said, “...We must move on from the reassuring Repetition of stale phrases to a new, difficult, but essential Confrontation with Reality....For the great Enemy of Truth is very often not the Lie - deliberate, contrived, and dishonest - but the Myth - persistent, persuasive, and unrealistic. Too often We hold fast to the cliches of Our Forebears. We subject all Facts to a prefabricated set of interpretations. We enjoy the comfort of opinion without the comfort of thought....Mythology distracts Us everywhere - in government as in business, in politics as in economics, in foreign affairs as in domestic affairs. But today I want to particularly consider the Myth and Reality in Our National Economy...”

This he spoke in regard unto the attitudes of the People of this Nation who were not living in the Light of current reality pertaining unto the Nation, but rather the “myth” that America was as it was when Our Forefathers wrote the Declaratory and Restrictive Clauses known as the Bill of Rights into the Constitution, nor the current economic condition.

The Constitution, which IS AMERICA, (and without it America is no longer “America,” but rather it becomes transmuted into some sort of UN dictated “Am-Africa.”) America under the Republi-Crat Regime's “leadership” is quickly becoming an “Am-Africa”; wherein which Our Constitution is being Trampled and Liquidated before Our eyes, not by a foreign enemy, but by Domestic Despots that tax Us for their nefarious deeds and incompetence.

It all by itself stole the power to dictate morality, laws, impose a State regulated religion of Secular Humanism, and has reduced the Supreme Law of the Land (the Constitution) unto a toothless MYTH that the American People still believes is protected by Oath of Office: oh, it also gave itself “absolute immunity” from Civil and Criminal prosecution. What this means is judges can convict you of crimes you have never committed; they can order you to be beaten in their presence and they and their deputies cannot be charged; they can conspire against your Constitutional Rights; they can and will deny You both Procedural Due Process of Law and Substantive Due Process of Law found in the Fourteenth Amendment; they have eradicated your Fundamental First,

Second, Fifth, and Tenth Declaratory and Restrictively Inviolate Rights as American Sovereigns; they routinely accept “lobby money” from private interests in their courts with which they weigh their opinions; and they cannot be impeached because they have formed a “masonic mob” that licks each others’ backends clean.

This leaves the Executive branch. The executive branch, as a result of the Judicial and the Legislative branches, has become impotent in the defense of the People's Constitutional Rights as Americans. In the United States today there are forces at work that are tearing apart our Unity as a Nation. One would be blind to see neither this Truth nor the potential service of the ASR/PCP in providing a Fair and Open Foundation upon for which Society to Regroup once again.

Along with the ASR (Assemblies of a Standard Raised which is discussed elsewhere); County wide Jurisdiction of the PCP online Platform providing every intelligent Citizen the opportunity to enter a Campaign for a local position at a minimal cost (ie..., \$1000 x 13 for each election cycle's Campaign positions);

Having displayed how We shall make Ourselves known, We must now prove Ourselves by showing the Way to overcome the various Social Evils and National Threats facing Us today with logic that cannot be gainsayed nor resisted.

A - The greatest National Threat facing Us today as a Nation is the continual erosion of Our Sovereignty as Citizens over those elected and/or appointed, the Bill of Rights, and the Fourteenth Amendment. Because I believe that the Sovereignty issue needs explained in Light of both Our Current circumstances and the Historical scenes behind Our Nation; We will examine the Bill of Rights, what they imply, and the Fourteenth Amendment which GUARANTEES their Declaratory implications.

Preamble

“ Congress of the United States begun and held at the City of New-York, on Wednesday the fourth of March, one thousand seven hundred and eighty nine...(In this first statement to the Preamble it is made Manifest that this is an Act of the Congress of the United States which occurred in the City of New York on March 4, 1789.)

“THE Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a Desire, in order to Prevent misconstruction or abuse of its Powers, that further Declaratory and Restrictive Clauses should be added: And as extending the ground of Public confidence in the Government, will best Ensure the Beneficent ends of its Institution...”

In order to understand the significance of this second statement, it is necessary to understand the History behind it...

On June 7, 1776 Richard Henry Lee of Virginia presented to the Second Continental Congress what became known as the Lee Resolution. The Lee Resolution proposed three things to the new Congress:

- 1 - A Declaration of Independence from Great Britain.**
- 2 - Alliances with foreign powers against Britain be sought out.**
- 3 - A formal confederation of the States be made...**

On November 15, 1777 an Articles of Confederation was agreed upon by the Congress. The last State to ratify it was Maryland on March 1, 1781, and it remained the ruling Document of the United States of America for eight years...

There was, however, various flaws to be found with it. The People, having just fought a war with Britain over their Civil Rights, were non too eager to place themselves back into a position they just fought themselves out of! And so, as a result, they made Congress purposefully weak;

1 - The Congress had no power to tax the people to raise revenue. It could only ask the states for money or get loans. When it did ask the states for money, it had no power to force them to comply, so most of the time the states didn't send the requested money, yet the Congress was supposed to oversee military affairs and regulate the economy.

2 - Another problem was that each state had one vote. This was inherently unfair to the larger states because they were asked to contribute more because of their size, yet had no greater say in how things should be done.

3 - Congress was supposed to control the military, but had no power to impose taxes to pay for it. It also had no power to require people to serve in the army. Instead Congress would send requests to each state to supply troops, which many times went unfulfilled. This is one of the reasons why George Washington's Continental Army was continually undermanned.

4 - The Congress had no authority to require delegates to even meet. States would appoint their delegates, but they might or might not show up to scheduled meetings. This made the course of conducting business extremely slow. It was so slow that the Peace Treaty with Great Britain, which had already been signed by the ambassadors, sat for months in Congress because there weren't enough delegates present to vote on it!

5- -Congress could make decisions, but could not enforce them.

6 - Congress could not regulate trade between the states. Instead, each state created its own trade laws, rules and tariffs. This created a confusing set of regulations from state to state and created a great deal of competition from state to state in trade matters.

7 - Each state was considered to be a completely sovereign entity that could do whatever it wished apart from the specific things mentioned in the Articles which were given to the federal government, which included the right to make war, control foreign diplomacy, control weights and measure and act as an arbiter between states.

8 - Decisions had to be made unanimously, so one state could veto a measure that all the other twelve wanted. As a result, the inherent deficiencies came to light on May 29, 1787 with what was called the "Virginia Plan"; whose sole purposed intent may be seen in its first declaration...

"...Resolved that the Articles of Confederation ought to be so corrected ; enlarged as to accomplish the objects proposed by their institution; namely, "common defense, security of liberty, and general welfare....";

Although some change was obviously needed, there was a division between what was known as the "Federalists" and the "Anti- Federalists"; The Federalists were somewhat against the Bill of Rights as they saw in their view that such an enumeration might give a future administration of Congress the power to oppose such; the Anti-Federalists demanded the Bill of Rights to be organized and endowed with Absolute Immunity from

any course of action taken by Congress. The Anti-Federalists had their way and the Bill of Rights were ordained as “Declaratory and Restrictive Clauses” that were to be forever held INVIOLE by Each and Every Citizen throughout the course of their lives. For instance, such punishments as imprisonment and sometimes death were recognized, but upon release each Right was fully retained! They were designed so that Government could never disarm the People individually, nor take away their Freedom of Speech, nor religion!

What is occurring today in the Courts of Our Nation more closely mirrors “Fascist Socialism” under the rule of an oligarchy (Rights interpreted by Judges) rather than the Democratic Republic possessing INVIOLE RIGHTS OF SOVEREIGNTY! The loss of ANY RIGHT via the false pretenses of the “felony conviction” is Anti-Constitutional and would have provoked a Second Revolution!

RESOLVED by the Senate and House of Representatives of the United States of America, in Congress assembled, two thirds of both Houses concurring, that the following Articles be proposed to the Legislatures of the several States, as Amendments to the Constitution of the United States, all, or any of which Articles, when ratified by three fourths of the said Legislatures, to be Valid to all Intents and Purposes, as part of the said Constitution; viz.ARTICLES in addition to, and Amendment of the Constitution of the United States of America, proposed by Congress, and ratified by the Legislatures of the Several States, pursuant to the fifth Article of the original Constitution.

Amendments

FIRST AMENDMENT - Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.(Our Government has Violated this Amendment via forced indoctrination of secular humanism in the classrooms, banning the

very Image of Christ in the Manger on Christmas; and are attempting to harness Free Speech through such things as “Hate speech” crimes.)

SECOND AMENDMENT - A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed. (Although the debate over whether this Right is reserve to the “People” collectively, or to the “People” Individually was ongoing for many years, on June 26, 2008 the Supreme Court ruled that it was an Individual Right. However, they also ruled that it was NOT A DECLARATORY AND RESTRICTIVE CLAUSE, making it an ABSOLUTE RIGHT; but rather that it is a “privilege” that can be revoked at will by the State. This is Dangerous unto Our Republic, for it not only nullifies all of the Bill of Rights as Declaratory and Restrictive Clauses forever Inviolable, it also annihilates the Fourteenth Amendment!)

THIRD AMENDMENT- No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.(The purpose of this Amendment was Two-fold.

1- The Colonists felt that they were being force to pay taxes for that which they themselves were able to perform. You must remember, the Right to Keep and Bear Arms existed long before the Constitution. In fact, even in Britain, firearms were REQUIRED by each and every man for the defensive abilities against both foreign insurgents as well as domestic threats.

2- The People preferred a Citizen army over a federal standing army in their midst; which would ultimately become a threat to them itself.

FOURTH - The Right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrant shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.(This Amendment was Ratified because the British Government basically viewed the States

as a Money Making enterprise. For which cause, the Citizens quite often did whatsoever they could to retain their income for themselves: for which cause the British would often spy upon and break in to take what they wanted. Also, they would arrest anyone whomsoever they would without probable cause. The States after defeating the British had no desire for a federal government that would do the same as they that they just vanquished.)

FIFTH - No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.(This Amendment states that a Citizen cannot be convicted of a crime bearing the death penalty or felony conviction without being indicted by a Grand Jury of his or her peers. To say that this Right which prevents wholesale "felonization" of an entire Nation for "crimes" of a non-violent, non-sexual, and non-treasonous pursuit has been trampled on in an attempt to un-Constitutionally disarm one out of ten Americans has not occurred would indicate stupidity and blindness upon the part of the observer; and the Gun Control Act of 1968 as well as the Domestic Violence Act have stripped untold Millions of their Inviolable Right!)

SIXTH - In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defense.(The current short coming of this Amendment is found in the fact that most public defenders work

with the DA to convict the accused of something to suck money out of them by charging them with multiple charges under the threat of excessive punishment, and the showing the “leniency” of the plea bargain; that’s how they make their living.)

SEVENTH - In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any court of the United States, than according to the rules of the common law.(This Right has been eradicated in Pennsylvania for the sake of convicting everyone of something without a Jury for all crimes whose maximum sentence is less than one year in prison. They didn't set any limits on the fines though; and if you don't pay, they will re-arrest you for not paying them for what they did to you : and you ain't allowed to have a Jury trial then either!)

EIGHTH - Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted. (I ask You, is the act of stripping the Inviolable Rights of a young American Citizen for life for growing marijuana in a flowerpot “cruel and/or unusual punishment?”)

NINTH - The enumeration in the Constitution, of certain Rights, shall not be construed to deny or disparage others retained by the people. (State; thereby destroying the Tenth Amendment.)

TENTH - The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the People.

Here is discovered the meanings implied by “Declaratory and Restrictive Clauses.” The “powers delegated” to the Federal Government, which are Declaratory, are the powers to levy taxes, set the standard currency, and to levy war. Powers prohibited to infringe upon the States, which are Restrictive, are the Bill of Rights (which most certainly includes the Right to Keep and Bear Arms.) The only thing from which a person indicted by a

Grand Jury and convicted of an “infamous crime” (For, without the indictment of a Grand Jury it is Constitutionally impossible to be convicted of an “Infamous Crime” which is what a “felony” is,) is barred from is serving in Government; not from owning a gun. Every other issue within the Republic is either a State issue that is determined by the vote of the People in accordance unto the Platform of the Political Party for whom They Vote; or if it is an issue of National consequence, such as sodomites in mini skirts parading about the Armed Forces (within which Citizens from each State may be required to serve with in time of major war), then in accordance unto the required votes of Congress shall the outcome be based upon the Platform provided by the Political Party the People elect to enact their Will.

FOURTEENTH SECTION 1 - All persons born or naturalized in the United States, and Subject to the Jurisdiction thereof, are Citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of Citizens of the United States; nor shall any State deprive any Person of Life, Liberty, or Property, without Due Process of Law; nor deny to any Person within its Jurisdiction the equal protection of the laws.

Here once more We find it un-Constitutional to violate any of the Enumerated Bill of Rights for ANY reason whatsoever including “felony conviction.” The States do have the power to execute, imprison, and/or confiscate and impose fines for violations of Legislative statutes in accordance unto Due Process of Law; but once again, NOT the authority to eradicate an Individual's Declaratory and Restrictive Rights!

As pertaining unto Due Process of Law, there are two types; Procedural and Substantive. Procedural Due Process of Law deals primarily with what is termed “Doctrine of Precedence,” or, “Stare Decisis.” It defines how the Court is to conduct itself in the proceedings of a complaint as well as what is required for conviction and /or judgment of sentence as a result of

previous rulings of a higher court; as well as the procedures to be followed to give the court “jurisdiction” to proceed with the hearings.

Substantive Due Process of Law deals primarily with guaranteeing each Citizen their Substantive Rights as Americans in accordance unto our Constitution. However, when “Procedural Due Process” has become the epitome of Pattern and Practice malicious to the Substantive Rights of Individual Citizens - then they have most certainly evinced a design to bring Us under absolute despotism.

Now, having attained a thorough grasp of what is at stake as the Republicrat Regime continues to eradicate the Constitutional Rights of every American Citizen, acts which have become THE greatest threat to Our National Security, let Us declare Our Solution...Although this at first may seem as if I am attempting to grow the National Debt by expanding the powers of the Federal Government, and create an even greater risk to the Powers retained by the People, I am not. What We need is an expansion of the Homeland Security Agency. A department must be created that does nothing but investigate judges, DAs, politicians, and police that violate their Oaths of Office or use their position for self inurement.

Upon receiving complaints from Citizens, and perceiving that they have legitimate grounds for indictment; they shall proceed to present the evidence to a Grand Jury of local Citizens; upon indictment, they shall proceed to drag that judge from the bench, tear that cop from the car, rip that politician from its office, and formally charge them with Federal Crimes against the Constitution and the People it protects: in short, TREASON.

Because Federal “Under Color of Law” statutes already exist, there is no reason to rewrite them. And then We must ask Ourselves, “Should a two-faced idiot that betrayed the People’s trust, stole from the Nation, and ran it into the ground receive a pension therefore?” Obviously the answer is “ No.” Therefore a judgment of not only a prison sentence shall be issued, but pensions revoked, and a Class Act lawsuit by the People. After

a couple of thousand treasonous despots are so removed from Society at large in such a manner, I believe that Civil Servants will begin to think twice before betraying the People for their own benefit! Although the pretentious liars of the Republi-Crat Regime will say, “ We already have the FBI that does that...”, the fact is that the FBI does nothing more than lick their backends clean and is need of being purged itself! For which cause, this proposed Agency must and will possess the Absolute Power of the Supreme Law of the Land; as well as Absolute Immunity from all except the Common Citizen. Howbeit, the Sovereign Citizen has nothing to fear from them, because the limited scope of the jurisdiction of their Duties is limited to Constitutional Crimes against the Citizens by Traitors and Perjurers of their Oaths of Office.

(The only other groups of despots that will have something to worry about as pertaining this Agency are so called “secret societies” that are nothing more than local mobs that meet at their lodges to discuss how to further prey off their fellow Citizens through governmental implants.)
